There will be no remuneration for your contribution to the presentation. All participants in the programme (speakers, moderators, organisers) will receive a free ticket for DMEA 2021 if required.

3. Non-implementation/postponement of the event

In the event of closure/disruption of the venue or for reasons of force majeure, Messe Berlin GmbH is entitled to cancel or postpone an event.

Please note that the programme items of the DMEA are generally planned as a presence format. However, depending on the development of the corona pandemic and the respective restrictions, we reserve the right to implement selected programme items in a purely digital format or to cancel them.

In this case, the bsg will inform you as soon as possible. Claims for reimbursement of expenses are excluded in the event of timely cancellation of the event.

4. Personal prevention

If you are prevented from attending on the day of the event or are unable or unwilling to make your contribution for other reasons, please inform the bsg as soon as possible. In this case, we would ask you to find a replacement speaker (after consultation with the person responsible for the session). The bsg reserves the right to cancel the programme item if no adequate replacement can be found. Reimbursement of any expenses will be checked by the bsg if necessary.

5. Data protection
